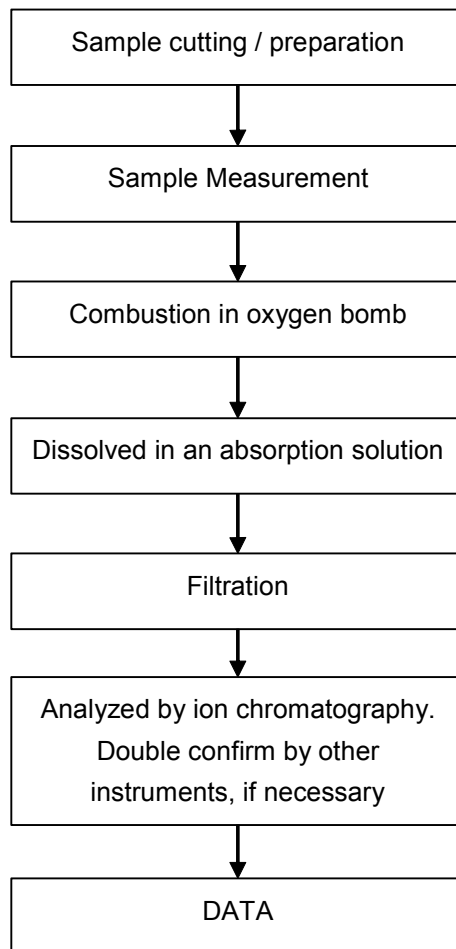

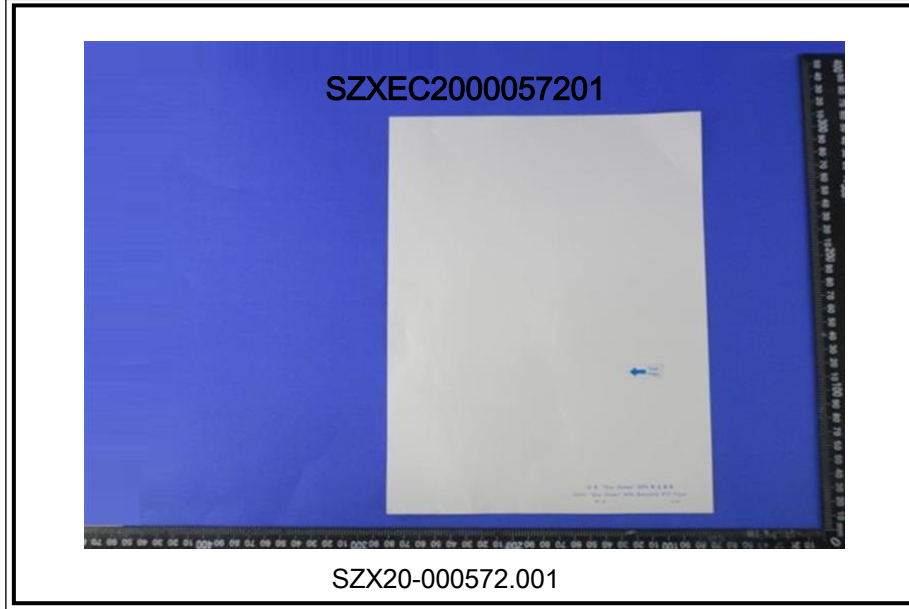
Halogen Testing Flow Chart
